Another year has passed and what a gift it is to have spent another year with the St. James community of faith. 2014 was a year filled with milestones and causes for celebration, both vocationally and personally for me. I finished my first full year of ministry with this community and began to form relationships, really getting to know many of you - beyond simply learning first names! What a blessing it is to serve this church along with Pam and Susan, as well as SuAn, who I like to call the St. James "Office Ad-MINISTER." It has been a busy year and at the same time a wonderful year.

In addition to my regular duties at St. James - leading worship, presiding at sacraments, visiting, pastoral emergencies, weddings, funerals, attending meetings, planning with the newly-formed worship team (who are amazing!), planning programs/events/workshops, etc., with Pam, Susan and SuAn, I also have been working away on my responsibilities to East District. This past year the East District Program and Agenda Committee transitioned into a Conference Committee as my term ended as chair. I now sit on East District Education and Students, a discernment committee for a local inquirer, the worship planning committee for the 200th Anniversary of Methodism, Pastoral Oversight as chair and the East District Executive. How is it possible to sum up all of those things that happened, all of the work that many dedicated volunteers completed, all the worship services, bible studies, committee meetings, conversations had, celebrations of life and death? How do we reflect on where we have arrived after another year of service, community and ministry, to best decide where to go next from here?

These questions got me thinking about the Ecclesiastes reading I've included above. I'm sure we have all heard and read this so many times before, usually at funerals. As I sit and reflect on the year that has past many things come to mind.

One aspect of ministry here with you that especially stands out is the warmth of hospitality that is shown as I make pastoral visits to the sick and shut-in of the congregation. Many times I have been referred to as family when I visit and this is indeed a privilege and honor. To be afforded that very aspect of hospitality when a loved one or family member is shut-in, sick or even dying is a great part of ministry with you.

With this being said I continue to visit the sick and shut-in of our congregation. This list is always evolving and I want to deeply thank those active members of the congregation who continue to keep me up to date on the needs of those who are not well or mobile. In reading this

report if you know of anyone who would like a visit or who wish to receive Holy Communion in their place of residence please let me know.

While most of my visiting takes place in a place of residence I often can be found on the telephone catching up after someone has had a medical procedure, or just to say "hi" I will be by soon. Pastoral Care through the "tely" continues to be an important part of the ministry of visitation.

I visit many nursing homes in our city and surrounding communities. Again, congregants places of residence continually change with levels of health and it is most welcome when family members keep the office up to date of any changes. Over the years we have had congregational members in almost every nursing home in the city and it too has been a great pleasure to visit members as they adapt to life changes in their new home.

This year has also been a huge year of transition for the residents of the Escasoni/Hoyles Complex (the new Long Term Care facility). It is a very important part of the outreach ministry of St. James United Church and has been for many years. Many congregational members helped the pastoral care team with the actual physical transition of patients to the new facility by being on hand if they needed to talk or just needed a friendly face.

We continue to work out a few glitches as the facility is physically much larger than the old facility. Since the move to the new facility we are also finding more patients worshipping with us on the second Tuesday of the month. Help is continually needed and I encourage you to become a volunteer through ministry at the new long-term care facility (Escasoni/Hoyles Complex). Transporting residents to and from worship includes pastoral care through conversation and fellowship. As well as the physical presence during worship is extremely valuable and important.

Thank you to all the volunteers who continually give of their time with this ministry. We have had to begin earlier on Tuesdays to get all residents down to worship and this is greatly appreciated. All patients who come to worship with us so enjoy our time together. They find it spiritually moving and the level of fellowship experienced through our ministry is really wonderful. Thank you to Phil Saunders who plays the piano regularly for our worship and also to Doreen Brown, the AOTS Men's Group and all others who come when asked. The St. James Guitar Group worshipped with us in February and serenaded us with some classic gospel favorites as well as many "love" songs for Valentine's Day.

I continue to sit on the Pastoral Care Committee at this complex as well as visit patients on an on-call emergency basis.

I could not let this report pass without thanking the congregation through the Ministry and Personnel Committee for affording me the opportunity to take a sabbatical for the months of July, August, September and October. It truly was a time of renewal and refreshment, not only in my professional life but in my personal life as well. As many of you know this past April the Newfoundland and Labrador Conference of The United Church of Canada cancelled funding on Memorial University and Marine Institute United Church Chaplaincy. I had been the chaplain at

MUN since 2001 and transitioning out of that ministry was a challenging part of my professional life. Being on sabbatical was able to help me discern my feelings and thoughts with that part of my professional journey ending as well as the overall Conference's decision to end that vital and important outreach ministry of the United Church in this province.

In saying this, it was wonderful to be able to read at leisure, and spend the summer months with my children, Julia, Nathan and Sophie, as well as Scott, my husband. I spent many glorious hours in my garden at home. I thoroughly enjoyed spending more time on Gambo Pond at our cabin. Sabbatical hours and days are a gracious gift of life in ministry. Thank you for that. I came back to work extremely thankful and very grateful for that time away.

Attending to worship and other aspects of ministry when Rev. Terrie is absent keeps ministry new and always challenging. I want to say a heartfelt thank you to the ministerial staff for a continued great team experience. While we are always in transition and discerning who we are as Christ's people in this day and age, it is good to be doing that with Susan and Terrie. Thanks to all others who support in any way from committee members and chairs to other staff at St. James. A special thank you to SuAn for her patience with me and my lack of computer skills[©], for continually booking visits, and for her gentle, giving spirit.

Christian Education 2014

As always, things have been busy with programs for children, youth and adults throughout the year.

Our Sunday school now offers 4 weekly programs: Nursery for infants -3 years, Godly Play for ages 4-7, Connect for ages 8-13 and Echo for teens. We also took time to work on presentations such as the Easter Drama led by Brenda Nyatanga and the White Gift play led by Rebecca Pike. The Sunday school also collected seeds for the Sunflower Project in High River, Alberta.

For the adults we held a Bible Study presented by Rev. Terrie on the book of John and three other studies (Embracing Emergence Christianity, Embracing an Adult Faith and Animate: Bible) with Susan. For those who like to move, there was also a session of Sacred Circle Dance as well as Yoga with our Office Administrator, SuAn.

We held our annual fundraiser, the Pancake Supper, on Shrove Tuesday to start the Lenten season. Thank you to the AOTS cooks for helping us yet again. Maundy Thursday found us gathered in the Multi-purpose room with youth and other members of the congregation to watch Jesus Christ Superstar followed by a discussion and an Agape Meal. To end Lent, we continued our tradition of the Good Friday Walk.

In 2014, 7 youth and 1 adult confirmed. There are 8 youth and 3 adults in the class preparing for confirmation in 2015.

The Liturgical dance program continued and in September expanded to two groups. The monthly movie nights have returned as part of our programming and a new Young Adults group started.

Over the year, we held two Youth Retreats. January found us at the Rotary Sunshine Park for a two-night retreat. Ten of our younger youth attended this event. In October, we pulled off an event on very short notice when the planned Conference Youth Forum had to be cancelled at the last minute. This event featured guest speaker David Csinos founder of the Faith Forward Conference for Children and Youth Ministry.

Over the summer 4 of our youth participated in the GO project in Stratford, Ontario and Rebecca Pike was hired to be Site Staff for the Go Projects in Stratford and Toronto. Here at St. James, we were GO Project hosts to 16 youth and leaders from across the country in early July. August saw us sending 5 youth and young adults to Winnipeg for the national gathering of United Church Youth known as Rendez-vous. One of our youth, Chelsea Skanes, presented two workshops at the event as did Rev. Terrie. Susan Sheppard was part of the organizing committee for the event and was to have presented workshops as well but could not attend due to illness.

2014 was indeed a busy year and 2015 is promising to be the same. Thank you for your support of the programs and work of CE, especially the GO Project.

The purpose of this type of visit to our home/sick and shut- in members is to reach out and minister to those who cannot come to church because of their health. This ministry provides fellowship, simply listening, holding hands and praying with them.

In 2014 there were 10 members, some homebound, assisted living centers or, residents of nursing homes. A total of 33 (thirty three) visits, 2 (two) telephone calls were conducted, and a number of "Thinking of You" greeting cards were sent out to a home member out of province.

All members were visited over the Christmas season, the team mark this occasion as extra special. This year the UCW purchased beautifully wrapped gifts of chocolates, Christmas and prayer cards and presented them to each member during the Christmas Visits. These gifts are very much appreciated, the expressions on their faces tell it all.

Sad to report we lost three (3) of those members during the year. Marie Pike (French), Sylvia Martin and Violet Hodder. We will remember them always with caring thoughts and prayer.

Rev. Pamela is kept abreast of any illness or hospitalization of those members and will visit them once notified.

We have a team of 4 (four) volunteers who are dedicated to the ministry of visitation. The goal of this ministry is to get to know those wonderful women, to keep them abreast of what is happening at UCW and the church, and let each of them know that they are still a cherished part of our church family. We offer warm smiles and hugs which always brightens their day.

Property Committee 2014 Annual Report - St James United Church

This Property Committee report presents the maintenance activities for the year and the actions that we have taken to preserve our asset, utilize our own human resource expertise, and seek to stay within the \$5000 maintenance budget approved by Council. This past year the Committee stayed within the budget that was provided at the beginning of the year.

No major projects were undertaken in 2014. We did receive a quote of \$1600 to fix the potholes and other asphalt areas but the work was not completed due to budget restraints. UC Conference office and MUN have been contacted for parking lot financial or other support to carry out repairs during the summer of 2015 which has been favourable to date.

We do still have a nagging leak issue with the windows on the west side of the church that will be looked at when weather permits. An infiltration test has been carried out on the windows to determine the leak location and rectify same. It appears as if the window design is not the best at the junction where the small opening windows meet the fixed window frame and a solution has been developed to repair same and carry out a full recaulking on the outside.

A number of zone valves for heating the church are giving us a little heartburn with the 50 year old valve for the church Sanctuary scheduled to be replaced with a modern design this upcoming summer. We did have an electrical inspection carried out with no major issues identified except the older electrical panels in the church and auditorium which are still functional and safe. It was recommended that separate light switches be installed for the lighting in lieu of using the panel circuit breakers as switches. One of the main electrical junction boxes within the commercial stove in the kitchen malfunctioned in December and had to be replaced at a cost of \$850.00.

Your Committee, along with Council and the Ministers, will be looking at the stained glass window initiative for the church Sanctuary windows. Further dialogue /information will be forthcoming to the congregation in the summer of 2015.

It is proposed that we relocate the baby barn on the church property in the summer of 2015 to take care of our maintenance equipment and storage and make it easier for our maintenance personnel to move equipment.

The ongoing and reoccurring building maintenance and inside cleaning, lawn mowing, snow entrance / exit doors, office management of property were also performed for the most part by hourly paid staff.

The gull problem on the church roof is still a little nuisance re aesthetics and will be reviewed again in the coming summer. The proposal from the professional firm ORKIN in the amount of \$9600 has been reviewed by Council and was not within our financial capabilities in 2014. A cheaper solution such as the bird on a flex wire, presently being used by Mile One, is being considered.

The snow clearing /ice control agreement in place with MUN for the past year has progressed very well without any major difficulty to St James or its congregational members. A number of passes are available for special occasions and MUN vacates the parking lot for St James funerals and other special functions. New parking lot lines and asphalt repairs, a priority, will be carried out early summer of 2015.

The budget for the operation and normal maintenance appears to be sufficient to keep the operations moving forward in a positive direction. The heating cost during 2014 was a little less than normal for the weather encountered and should be reduced significantly for 2015 if the price of oil remains low.

The difficulty arises in maintaining the budget amount when the Church requires a major capital expenditure or an allowance for unknown emergency expenses.

The Property Committee also thanks those who assisted with the flower beds this past year and we will be seeking assistance from the congregation to help with the planting and maintenance of the flower beds and trees around the church during the coming summer.

The Committee's goals for 2015 are the following;

- To maintain St James operated facilities to the standards that will provide safe, long-term viability for staff, congregational members and external rental users.
- To research and remain current on new products and equipment use in the maintenance and operation of the buildings and to seek our own resources to assist with related work that require attention.
- To provide assistance with the preparation of the annual operational budget, and provide input into any capital expenditures required for the buildings within the next 5 years.
- To ensure all work is performed in accordance with workplace health and safety standards, risk control guidelines, and that all procedures required by the Provincial Government is adhered to.

I would like to thank the direct members of the Committee: David Hapgood Jr, Keith Davis, Oliver Wellon, Bruce Windsor, Lorne Hollett, Linda Martin, Charles Pelley and especially SuAn

Randall with assistance with booking and invoicing, rental schedules and other property related requirements along with her regular duties. A note of thanks is also extended to others who assisted in other aspects of keeping the facility and grounds in good condition, plus special note to the church elders and especially Phil Saunders for the continuous assistance, recommendations and support along with our own St. James Ministers who keep us in tune and who also assist in property matters.

The Property Committee is always looking for new members either to serve on a task report or just for an individual repair that has been identified. This would provide the opportunity for congregational members to support the church through assisting with a task /repair and not have to be involved in a full-time committee.

Let's look forward to another successful year with the St. James family and friends.

Administration and Communications - Janice Winsor

As SuAn Randall, our office administrator, completes her daily tasks, she follows the church calendar, planning ahead for each season. For the past year, a very large work-in-progress involved, when time permitted, the gradual documenting of her daily duties for use in preparing a procedures manual. This manual will help us in our planning for supplies and assistance required to complete these tasks.

Most weeks SuAn prints 160-200 bulletins for the Sunday service, but this number changes with the seasons. Because the services are projected on PowerPoint, we are hoping to produce fewer copies and save on paper and copier costs. Please feel free to share your bulletin whenever you can.

After finalizing a new contract for our photocopier in 2013, we started working on figures for a new telephone system. In May, Rogers installed new telecommunications hardware to bring our system completely up to date to make us more efficient, and now you can call us and select the party you wish to speak to and leave a message for that person without going through the main office. We get one bill for both our telephones and internet, with a reduced monthly rate.

During the summer all the computers in the church offices were updated with the same operating system and Microsoft software.

This summer Annie Brown and Joel Le Feuvre were hired under provincial and federal grants. Annie helped SuAn look after the office and update our family database and historical records, and Joel worked on archival files and made a database of all the music in the church. Annie and Joel were quite engaged in their tasks and did a great job of bringing us up to date with special projects identified during the year.

After many years of dedication as our Archivist, June Jones has stepped down and Noah Morritt has kindly agreed to continue her work. Noah and June recently met with members of MUN Archives and the Association of Newfoundland and Labrador Archives to discuss policies and procedures and projects that will need to be done in the next year.

In November our committee offered to find a way to involve more families provide assistance and food for our coffee hours. We made phone calls to 50-75 families in our zone mail list but we were very disappointed with the response. We contacted only about 20 percent of the people we called, and many of those weren't able to assist us at the time. So we are kindly asking you to call SuAn if you would like to provide some food for coffee hour at least one time during the year. Coffee hours are held on the third Sunday of every month, excluding July and August.

We published the <u>Visitor</u> three times and continue to send it to you via email or in hard copy, as you wish. Prior to last year we printed more than 600 hard copies of each publication and our zone captains brought them to your door; we now print less than 350 and email the rest, resulting in considerable savings to paper and copier costs. If you would like to receive an email copy, please call SuAn.

We administer 58 zones to distribute paper copies of our communications to you, and we use Canada Post to mail to 30 members. Our zone captains are committed to getting church information to you, and we are very appreciative of their dedication. As you know, postage rates have doubled this year. Please help us reduce postage costs by arranging to pick up mail instead of having us mail it to you.

Thank you to my committee members. Although we have very few face-to-face meetings, we share information and ideas through email and get the work of the committee done. Thank you especially to Glenda Winsor as she continues to maintain the website www.stjamesuc.org. Also, many thanks to SuAn who works tirelessly to respond to all your requests.

2014 ANNUAL REPORT ST. JAMES AOTS (MEN'S) CLUB

INTRODUCTION:

During 2014 our AOTS (Men's) Club maintained an active role in the life and work of our St. James congregation through outreach, congregational worship support, stewardship, and volunteer support. Our regular monthly dinner meetings, with the dedicated support of our kitchen helpers, were well attended and we welcomed a number of guest speakers who spoke on issues of member interest. Music and Liturgy/Worship Team

Christine Tiller, our Organist and Choir Director, tendered her resignation in May. We sincerely thank Christine for her dedication to the Ministry of Music at St. James and her commitment to the Senior Choir. We wish her all the best in her future endeavours. Throughout the summer we availed of a number of musicians from our community, including Bob Rose, who agreed to provide support while we advertised for a replacement. Of particular mention is Mian Chen, a student at MUN, who is also pursuing certification to the Canadian College of Organists. Her skill and ability on the organ enthralled all those who had the pleasure to experience her talent. We were extremely fortunate to have two very qualified applicants for the advertised position which resulted in the development of co-Music Director positions currently occupied by Amy Dalziel and Sophia Werden-Abrams. We look forward to continuing on our exciting journey in the Ministry of Music with these Directors.

In September, the Worship Team replaced the Music and Liturgy committee. This team, is comprised of the Ministers, all music Leaders, a representative from the Worship and Sacraments Committee and two persons representing the congregation. The purpose of the Team is to develop the schedule of worship services; provide support and assistance to the Ministers in planning, preparing and presenting worship services; coordinating the Ministry of the Word with the Ministry of Music; including intergenerational and other alternative participation to ensure the congregation is experiencing a meaningful and spiritual worship. The Team meets as is necessary, but at least once a month to discuss and plan the services for weeks in advance. We are currently working on the Palm Sunday, Good Friday and Easter Services as well as finalizing the worship schedule through to October, 2015.

Communion Report

A year ago I started preparing the Communion table and arranging for servers to serve Communion. I was a bit apprehensive at first but knew that they were having trouble finding someone to carry on the job that Mary Hood had been doing for the past seven years. So I decided to give it a try and I am so glad that I did. Mary spent a fair bit of time preparing me for the job. She walked me through everything. She also has been available anytime for me to call and ask questions. She had everything written down for me so I could have it to refer to if needed. I am so very thankful and appreciate all she has done, she has made the transition so much easier. I enjoyed the time spent learning from Mary and feel blessed to have gotten to know her better.

We have always served Communion in two ways at St. James, in the pews or by intinction. During most of the winter months we serve Communion in the pews and in the summer and during Christmas and Easter we serve by intinction. I like to use bread and roll mix for the bread when serving in the pews because it gives me enough bread for the loaf of blessing as well and cuts down on cost. For intinction, I use pocketless pita because when cut it doesn't split apart and I can cut it longer so that it can be dipped into the grape juice without causing contamination. We also serve gluten free alternative for Communion. I was using rice crackers but they were a bit too crunchy so now I use rice cakes instead. I have Rev. Terrie and her mom to thank for the suggestion.

Everything has been going smoothly for the most part. Of course, whenever starting something new there is bound to be a few hiccups along the way. I have been just going with the flow, learning from these little mistakes and sometimes laughing at myself. For instance, forgetting to uncover the elements. However, some of these mistakes become happy accidents. There was one particular Sunday that I forgot to slightly cut the loaf of blessing for ease of breaking, like I usually do. Afterwards Rev. Terrie said that she felt that it was much more symbolic to leave it uncut and just break it by hand. I have been leaving it uncut ever since.

It has been a very rewarding and enjoyable year. It has been wonderful to get in touch with the members of the congregation. I have never been good with names but I am getting a little better. I have enjoyed the time spent with those that have volunteered to help. Chatting as we work together has been a lot of fun and a wonderful way to get to know people a little better. My goal is to get more people involved in serving Communion. Besides serving Communion, there is a fair bit of work involved in the clean up afterwards. So it is wonderful to have help with this. As they say, "many hands make light work." I would like to thank all of those who took part in serving Communion this year, I couldn't have done it without them.

I would like to encourage the servers and the congregation to find Communion a pleasant and happy experience. I like to see lots of smiles and people sharing this beautiful experience in a friendly manner.

I encourage anyone who is feeling like they would like to do some sort of volunteer work at the church, but feels too nervous, to give it a try. It is a very rewarding and worthwhile experience and there is always someone to help you along the way.

It has truly been an honor and a pleasure to prepare the Lord's table for my faith community this past year and I hope that I will be able to successfully continue for many years to come.

East District Delegate Report 2014

East District Spring Meeting was held at Cowan Heights United Church, St. John's, NL, from May 23-25, 2014. The special speaker was Rev. Rob Fennell, Associate Professor of Historical and Systematic Theology at the Atlantic School of Theology. He spoke on the theme: "If not us, then who?" The main point of the conversation concerned the Gift of God calling to us in this time to be the people of God in the world. If we do not receive and take up the challenge of serving the Christian mission, who will? Rev. Fennell discussed a few troublesome issues in our life together as a Church, such as time spent on nonessential issues, and things we like to bicker about such as fund raising. He offered seven functions that we should be concerned about:

- 1. worship;
- 2. teaching the faith;
- 3. serving others;
- 4. bearing witness;
- 5. building community;
- 6. proclaiming the faith;
- 7. reconciliation.

Patti Talbot, General Council Representative, gave a report on M&S and also showed slides of her trip to the Philippines after the super typhoon in 2013. \$1.6 million was raised by the United Church.

Highlights

Finance: Effective 2015, the assessment formula will change from the number of households under pastoral care to 5% of the total funds raised by the congregation givings, less M&S, exclusive of UCW, with a process available to consider exceptions on appeal.

Comprehensive Review and Models of Ministry, Task Group Report: The UC churches and congregations are changing. All have challenges; churches are getting smaller, amalgamating or closing. Diminishing resources, both financial and human, are all affecting our ability to make a difference in God's world. The Task Group heard that:

- 1. our church needs to change;
- 2. a sense of denominational identity as an open, welcoming and justice seeking church is needed, as well as a yearning to share that identity more clearly and publicly;
- 3. there is a need for governance that is simpler and more effective.

The Task Group has spoken with committees and other groups and is now turning to districts and General Council that will meet in August 2015 for the wisdom and expertise, experience and responsibilities that they are able to offer.

New models of ministry will be needed to meet the needs of a changing society. It is important for congregations to be informed of this decision making if they are to support the new mission as it unfolds.

The following issues were also discussed: Mission & Service, PAR, legacy givings, gifting, RRSP, RRIF, bequests, annuities. These gifts will ensure that the United Church will be there for future generations.

Notable Events: Moderator Rt. Rev. Gary Patterson visited NL from October 17-19, 2014. A celebration was held at Cochrane Street United Church with our St. James Guitar Group performing.

The 42nd General Council will meet in Corner Brook, NL from August 8-15, 2015. More information may be obtained from the UCC: www.unitedchurch.ca

This has been a learning experience in our United Church that is very important at this time.

Our Cemetery staff is very dedicated. They operate six days per week, sometimes under very difficult and challenging situations.

Project Grace

Year 3 of the Project Grace After-School Music Program at St. James United Church is well under way and what a great year it is!

In 2014, Project Grace was lucky to be the recipient of two major grants – an \$8,000 grant from TD MusiCounts and a \$9,999 grant from United Way Newfoundland and Labrador. Both of these grants were specifically designated to help Project Grace purchase the necessary instruments needed to run the program as it is, and to set it up for the planned expansion in the 2015-16 school year. Thanks to MusiCounts & United Way, Project Grace now owns 5 cellos, 18 violins, 4 flutes, 4 trumpets, 2 trombones, 4 sets of drum pads and 4 keyboards with stands and benches.

The Project Grace After-School Music Program has grown this year. We now offer 4 days of programing (Monday through Thursday between 2:45 and 4:15pm at the church), the students play in orchestra together, and from January to April all students have been invited to join our Chamber Music program! Additionally, the PG orchestral program now has a sister group, the Patricia Young Youth Choral Academy, which rehearses on weekends at Cochrane Street United Church.

The first performance of our Project Grace Youth Orchestra happened in December at our annual Fall Semester Showcase! Together the children performed Jingle Bells which was specifically arranged for our orchestra by MUN Composition student Jenny Griffoen.

Students in the chamber music have been working together to learn music for small groups – duos, trios and quartets – with various instrumentation. They've also been treated to the opportunity to work with one of Newfoundland's most renowned classical groups, Duo Concertante. Over the course of the rest of this semester, Chamber Music participants will get to work with other faculty and graduate students from the Memorial University School of Music.

Further successes for Project Grace in 2015 include being recipient of a second grant (\$4,500) from the Newfoundland & Labrador Arts Council, to support our teaching artist staff, and a grant of \$5,000 from the United Church Mission and Support Fund, given to the PG choral program at Cochrane Street United Church.

Project Grace now has 7 members on faculty, a team which we are looking forward to adding 2 new members in September 2015. Students have an exciting spring semester coming up, including a concert in the first week of June and summer music camps to follow in July and August. The semester showcase for the winter months will happen on the last weekend of March. Please stay tuned for details!

As always, Project Grace is grateful for the support of the St. James United Church staff and congregation. The church continues to be a safe and enjoyable space for our students to participate in their music lessons, and we are proud to be members of the St James family. For many of these students, without the free tuition and loan of instruments provided by Project Grace, community music making would not be possible. Project Grace is grateful to all those

Bridges To Hope 2014

On behalf of the Board of Directors and Staff at Bridges To Hope I would like to thank you for your generous support and continued commitment to Bridges To Hope. Your contribution of food, funds and volunteer time throughout 2014 has enabled Bridges To Hope to continue its very important work in the community.

In 2014 the Bridges To Hope Food Pantry served over 8,200 people and 1,800 of those served were children. With your support we were able to provide each client with nutritious food hampers that contained fresh fruit, homemade bread (from our community kitchen), milk and other food items necessary for health and wellness. Those food hampers are a lifeline for persons who are facing extraordinary challenges in their daily lives.

Our Food Pantry was staffed with volunteers from throughout the community, and community service organizations such as Canada World Youth, Elaine Dobbin Centre for Autism, Skills Link and Partners for Workplace Inclusion, to name a few.

The Community Kitchen has been very busy, offering health and wellness cooking programs to clients who include persons with physical and mental disabilities, socialization issues, persons who are elderly, youth who are homeless and /or at risk, expectant mothers, low income - employed and unemployed persons, families on assistance. Your support has ensured, that we are able to offer help to everyone – regardless of their life circumstance. Our Community Kitchen also prepares food for the Food Pantry including fresh baked bread, soup, stews and other home cooked meals.

Other programs offered by Bridges To Hope include education support initiatives such as **Bag To School** and **Passion For Projects**. In 2014 the Bag To School program provided over 900 students with curriculum based school supplies and book bags for students K-12 and in Adult Basic Education. The Passion for Projects initiative provided students with high quality school project (heritage fair and science fairs) supplies. Significant funding for Bag To School was obtained from the United Church Gifts with Vision fund.

The community has always been the cornerstone of support for the work being done at Bridges To Hope. This commitment was evident at the **2014 Chair'ity Dinner and Auction** held at the Sheraton Hotel in November. The event was a tremendous success with over 200 guests and significant funds raised to support Bridges programs. Special thank you to all those who contributed to the beautiful Church baskets that were auctioned at the event.

Bridges To Hope also welcomed a new Program Director, Heather Elliott. She comes to us after a successful career with CBC, the Liquor Commission, and Habitat for Humanity. Her tremendous enthusiasm has been infectious and is felt by both Staff and the Board.

To cap the year off, Bridges To Hope partnered once again with the Rotary Club of St. John's for the annual Christmas Hamper Campaign. Over 450 hampers were distributed to individuals and families from St. Andrews Presbyterian Church on Saturday, December 20th.
